MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into on 15th January 2020 ("Effective Date"), at Gondia and shall be in force for a period of 2 years i.e. till 15th January 2022 (the "term") by and between:

Nawegaon-Nagzira Tiger Reserve, Gondia (hereinafter, First Party) And
Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori (hereinafter, Second Party)
Where as Navegaon Nagzira Tiger Reserve, Gondia is mandate of habitat improvement in order to
augment the wildlife. For this purpose first party requires training of frontline staff, habitat assessment
and preparation of plan on basis of scientific and technical inputs, monitoring during implementation of
plan and periodical evaluation of habitat with assistance of second party commencing from 15 January
2020 until 15 January 2022.

Navegaon Nagzira Tiger Reserve, Gondia and Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori are hereinafter individually referred to as "Party" and collectively referred to as "Parties".

A. Introduction

- A. The aim of this MOU is to set out the framework for the working relationship between Navegaon Nagzira Tiger Reserve, Gondia and Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori.
- B. The MOU is associated with scientific and technical assistance for habitat assessment before intervention, preparation of improvement plan and periodical evaluation after intervention.
- C. The MOU sets out the roles and expresses the convergence of will between both organizations, a common line of action to achieve the objective. Also, the MOU sets out to shape the relationship between the parties and communicate clearly and unambiguously how each party will successfully work together and alongside one another.

Parties to the MOU

Navegaon Nagzira Tiger Reserve, Gondia is having office at Van Bhavan, Kudwa Road, TB Toli, Gondia, Maharashtra 441 614 and wishes to take assistance for improvement of wildlife habitat by scientific intervention through capacity building of field staff and preparation of holistic plan of habitat improvement and periodic evaluation to assess the impact on habitat and wildlife.

Mahatma Gandhi Arts, Science and Late N.P. Commerce College, is an educational institute located at Armori, Tal. Armori, Dist. Gadchiroli have team of experienced professors of various subjects including biological sciences. They have always involved in various project of scientific study, assessment, evaluation of natural resources of eastern vidarbha mainly in Gadchiroli, Bhandara and Gondia District.

Guiding Principle for Work:

The MOU shall begin on 15th January 2020 and shall be considered for renewal on 16th January 2022. The terms in this MOU may undergo a change in the project period and an addendum will be signed to this MoU for any change in the terms of the MoU.

Navegaon Nagzira Tiger Reserve, Gondia will be responsible for extending all the assistance to Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori. This assistance consist of transportation and accommodation to specialists and students those involved in the project without any cost.

Navegaon Nagzira Tiger Reserve, Gondia will be responsible for the following:

- Provide the infrastructure for training field staff
- > Transportation and accommodation facilities to specialists and students those involved in the project
- Providing the manpower, wherever it is found necessary during field excursion

Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori will be responsible for the following:

- Supporting Navegaon Nagzira Tiger Reserve, Gondia to prepare location wise preparation of habitat improvement plans.
- Capacity building of field staff
- > Pre and post-assessment of habitat improvement works
- Documentation of floral diversity
- Providing experts and technical manpower in the form of students
- > Following rules and regulations related to forest and wildlife

ARBITRATION

All disputes, differences or questions arising between the Parties in connection with this MOU, including but not limited to the construction of this MOU or the rights, duties or liabilities of either party, will be settled by Arbitration. Arbitration of any dispute may be initiated by one party sending a written demand for Arbitration to the other party. This demand will specify the matter in dispute and request the appointment of an Arbitration panel. The Arbitration panel shall consist of one arbitrator, if both parties can agree on one arbitrator. Otherwise, each party shall appoint its arbitrator and the two appointed arbitrators should appoint the third arbitrator who shall act as a Presiding Officer. The Arbitration proceedings will be conducted in accordance with the Arbitration and Conciliation Act of India, 1996. The site of the Arbitration will be at Gondia. All expenses of the Arbitration shall be borne equally by the Parties, unless the Arbitrators rule otherwise.

JURISDICTION

Subject to 'above arbitration clause, the jurisdiction in the matter shall be subject to the courts of Gondia only.

NOTICE OF TERMINATION

This agreement shall be terminated by either party by giving a written notice of 30 days.

Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori shall have the right to terminate the agreement upon giving a one week notice where:

Navegaon Nagzira Tiger Reserve, Gondia commits breach of any of the terms of this agreement.

Navegaon Nagzira Tiger Reserve, Gondia commits any act or omission which harms the reputation of Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori

Same conditions of Termination apply to Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori in case Mahatma Gandhi Arts, Science and Late N.P. Commerce College, Armori commits breach of any terms of this agreement, commits any act or omission which harms the reputation of Navegaon-Nagzira Tiger Reserve, Gondia.


Activity Under MoU between Nawegaon- Nagzira Tiger Reserve, Gondia and Mahatma Gandhi Arts, Science and Late N. P. Commerce College, Armori

Name of Activity: Identification and Seed collection of Palatable Grasses and Legumes (Session 2020 – 2021)

Grassland is important in Tiger Reserves, because they supply food and habitat for wild animals, birds, and help to maintain the food chain in the core area. In grassland not only grasses form majority of the fodder consumed by animals but legumes, other sedges are also consumed. Grass is a monocot plant that produces a large amount of biomass in a short period of time and by this they play a vital role in ecosystem. As an effort to understand the fodder potential of grasslands of Kalimati and Kawalewada a complete checklist of palatable grass species was compiled. The grasses with awns are consumed before the maturation and after the dispersal of awns.

Outcomes:

A total of 22 palatable grass species were documented. Grasses and legumes are identified and recommended for seed collection viz. *Apluda mutica*, *Dactyloctenium aegypticum*, *Dichanthium annulatum*, *Echinochloa colona*, *Ischaemum indicum*, *Iseliema laxum*, *Paspalum scrobiculatum* etc. and legumes *Aeschynomene aspera*, *Cajans scorboid*, *Crotalaria montana*, *Desmodium dichotomum*, *Stylosanthis fruticosa*, *Vigna trilobata* etc.
