

## 1. Background

Intellectual Property means the property represented by the product emanating from creativity of the human mind, human intellect and creative ideas. It can be an Invention, original Design, Trademarks, artistic creation, etc. These new activities brought about industrial, economical and cultural development in the society.

Intellectual Property is an asset and by acquiring a legal right over the property, the creator of the intellectual property seeks to ensure that he has exclusive right over it. Intellectual Property Rights (IPRs) are a set of exclusive rights protected by law which are accorded to creators or persons over their creations for a certain time period. An IP right holder can realize value from its intellectual assets through utilizing it internally for its own processes or share it externally through provision of goods and services to customers. The latter can be achieved through legal mechanisms such as licensing or assignment.

Intellectual Property Rights (IPRs) are considered as a barometer of R&D activities, encourages technology transfer, national / foreign direct investments & helps in technological / industrial development. Intellectual Property Rights (IPR) plays a vital role in enhancing the socio-economic prosperity of the country. Creativity and innovation are new drivers of the world economy. With the increasing relevance of Intellectual Property (IP) in this era of globalization, it is important to recognize the role which IP systems play in the growth of the Nation. Thus, there is a need to create large public awareness about the pivotal role of IPR in globalized knowledge economy. From last many years it was observed that, filing of IP applications in the country are not increasing despite significant contribution towards R&D by various students, institutes, scientist and R&D organizations. With the view to create awareness on the significance of IPR to the people from various sectors, our college organized a one day workshop on "Intellectual Property Rights (IPR)" at the college campus on 22<sup>nd</sup> February, 2019. The workshop was intended to cover various aspects of IPR like Patents, Copyrights, Trademarks, etc.

## 2. Aims & Objectives

The one day IPR awareness workshop mainly aims at establishing a basic level of IP awareness amongst the workshop participants, such that the chances of obtaining well-protected innovation (Patents) for their organizations.

### 4. Inaugural Session and Expert Talks

Sensing the importance for the protection of Intellectual Properties in today's globalizing knowledge based economy, M. G. College, Armori in collaboration with Cell for IPR Promotion and Management (CIPAM), Department of Industrial Policy & Promotion, Ministry of Commerce & Industry, Government of India, who provided expert resource persons, organized a one-day Workshop on "Intellectual Property Rights" on 22<sup>nd</sup> February, 2019.

In the Inaugural Session on 22<sup>nd</sup> February, 2019, Dr. L. H. Khalsa, Principal, M. G. College, Armori chaired the function and welcomed all the participants. Introductory talk was given by Dr. C. D. Mungmode, Organizing Secretary of the workshop, briefing the aim and objectives of the workshop. Mrs. Chhaya Satpute, Ex. Senior Documentation office, Rajiv Gandhi National Institute for Intellectual Property Management (RGNIIPM), Nagpur and Dr. Mrs. Ushoshi Guha, IPR Attorney, Nagpur graced the Programme as the Chief Guest. In their addresses as the Chief Guest, they highlighted the importance and need of Intellectual Property Rights giving the example of turmeric patent battle. In the chairperson's address **Dr. L. H. Khalsa** stated that IPR is beneficial for development of society and IPR safeguard the rights of intellectual property for the owner and gives the reward for creative efforts. Vote of thanks was proposed by Dr. R. N. Chavan, Co-ordinator, R & D Committee. After this, technical session follows.

**Mrs. Chhaya Satpute**, Ex. Senior Documentation office, Rajiv Gandhi National Institute for Intellectual Property Management (RGNIIPM), Nagpur, delivered expert talk in technical session one. She made a detailed presentation on the concept of IPR & its various aspects like patent, trademark, GI, etc., its benefits, importance of IPR in academia and commercialization of IPR. She started taking about intellectual property and intellectual property rights (IPRs) and legal benefits of registering patents and geographical indications. She discussed so many

example during her presentation on patents, copyright, trademark, etc. for increasing awareness on IPRs. She also showed some videos of Young Innovators explaining how they made their innovations and protected their rights.

Second technical session was started with the discussion of **Dr. Mrs. Ushoshi Guha**, Patent Attorney, Nagpur. She started with talking about legal benefits of registering patents, designs and geographical indications. Through citing further examples and small case studies she emphasized on the commercial value of registering Trademarks, Logos and Designs.

After the completion second technical session, four animated videos provided by CIPAM, Delhi, on What is IPR?, What are the types of IPR?, How can we protect the rights of our innovations? were shown to the participants.

After technical session participants share their view about IPR and showed their interest to protect their products/process in existing IPR system.

## 5. Participants of the programme

In this workshop on IPRs, there were 44 participants attending the programme which includes, faculties, research scholars from various colleges and Post Graduate students of the college.

Apart from participants from other colleges, 25 faculties of the college were also participated in the workshop.

Thus, there were totally 69 participants in the one day workshop.

## 6. Recommendations & Conclusions

As the topic of Intellectual Property (IP) itself is very new to the people, most of the participants were in the process of understanding the basics of Intellectual Property Rights. It was felt that some of the technical sessions based on IPR should be organised in future which would help in increasing the awareness about this subject.

Overall, the programme went well and all the dignitaries and concern person attended the programme and made it a very successful.

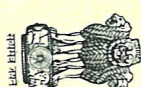

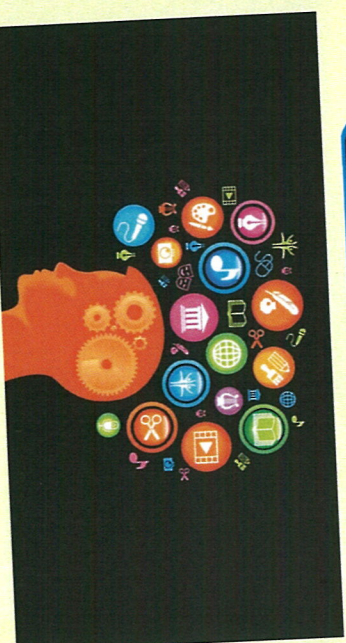
